

Letter of Support Template for Muhammed Emanet, owner of Jersey Kebab Restaurant in Collingswood, NJ

Our friend Muhammed Emanet urgently needs support from our community. As you may know, Muhammed came to the United States as a young boy. He is married to an American citizen, the father of two American children, and he and his parents are the owners of Jersey Kebab Restaurant in Collingswood, NJ. And, of course, he is an upstanding member of the community. The Emanet family has been working on their immigration status for years. You may recall his mother and father being placed in detention in the spring of 2025, and the subsequent vigils and letters of support that followed. **That community support made a difference.**

On June 3, Muhammed received an Intent to Deny letter from the U.S. Immigration Services. This means U.S. immigration services is planning on denying his application to adjust his status from “deport to permanent resident.” The Green Card Muhammed received though his wife is being held up, and he will remain in deportation proceedings along with his parents if they deny his application. Muhammed has three weeks to gather evidence as to why he should not be deported. This is where you come in.

Please consider writing a letter of support for Muhammed Emanet and delivering it to his email address or to Jersey Kebab Restaurant on Haddon Ave. in Collingswood **no later than June 30, 2026.** Those addresses are provided at the end of this letter.

Paragraph(s): Writer’s Identity and Background

Describe what you know about Muhammed's personal qualities, character, and his involvement and contributions to the community. Specific examples are extremely helpful.

Optional Paragraph: Hardship or Impact if the Case Is Denied (If Known)

If you know how denying his immigration case would impact the community, family, etc, you may include this information.

Paragraph: Overall Support and Opinion

Based on my relationship with Muhammed Emanet over the past [number] years, I believe that he is a person of good character who has strong ties to the United States through (family, work, community, school, business, etc.)

It is my sincere opinion that Muhammed Emanet deserves favorable consideration in his immigration matter, and I fully support his application.

Paragraph: Statement of Truth and Contact Information
